

Schedule I and II Substances — Lower Quantity Thresholds

Drugs and Threshold Quantities:

- **Methamphetamine:** 5g pure or 50g mixture
- **Heroin:** 100g mixture
- **Cocaine:** 500g mixture
- **Cocaine Base:** 28g mixture
- **PCP:** 10g pure or 100g mixture
- **LSD:** 1g mixture
- **Fentanyl:** 40g mixture
- **Fentanyl Analogue:** 10g mixture

Penalties:

First Offense:

- 5 to 40 years imprisonment
- If death or serious injury: 20 years to life imprisonment
- Fine: Up to \$5 million (individual) or \$25 million (non-individual)
- Supervised release: Minimum 4 years

Second Offense:

- 10 years to life imprisonment
 - If death or serious injury: Life imprisonment
 - Fine: Up to \$8 million (individual) or \$50 million (non-individual)
 - Supervised release: Minimum 8 years

Schedule I and II Substances — Higher Quantity Thresholds

Drugs and Threshold Quantities:

- **Methamphetamine:** 50g pure or 500g mixture
- **Heroin:** 1kg mixture
- **Cocaine or Coca Leaves (Ecgonine):** 5kg mixture
- **Cocaine Base:** 280g mixture
- **PCP:** 100g pure or 1kg mixture
- **LSD:** 10g mixture
- **Fentanyl:** 400g mixture
- **Fentanyl Analogue:** 100g mixture

Penalties:

First Offense:

- 10 years to life imprisonment
- If death or serious injury: 20 years to life imprisonment
- Fine: Up to \$10 million (individual) or \$50 million (non-individual)
- Supervised release: Minimum 5 years

Second Offense:

- 20 years to life imprisonment
- If death or serious injury: Life imprisonment
- Fine: Up to \$20 million (individual) or \$75 million (non-individual)
- Supervised release: Minimum 10 years

Other Schedule I and II Substances

Drugs and Threshold Quantities:

- **Other substances** (including Gamma-Hydroxybutyric Acid and Flunitrazepam): Any quantity

Penalties:

First Offense:

- Up to 20 years imprisonment
- If death or serious injury: 20 years to life imprisonment
- Fine: Up to \$1 million (individual) or \$5 million (non-individual)
- Supervised release: Minimum 3 years

Second Offense:

- Up to 30 years imprisonment
 - If death or serious injury: Life imprisonment
 - Fine: Up to \$2 million (individual) or \$10 million (non-individual)
 - Supervised release: Minimum 6 years

Schedule III Substances

Drugs and Threshold Quantities:

- **Substances** (including anabolic steroids, codeine, hydrocodone combinations, and some barbiturates): Any quantity

Penalties:

First Offense:

- Up to 10 years imprisonment
- If death or serious injury: Up to 15 years imprisonment
- Fine: Up to \$500,000 (individual) or \$2.5 million (non-individual)
- Supervised release: Minimum 2 years

Second Offense:

- Up to 20 years imprisonment
- If death or serious injury: Up to 30 years imprisonment
- Fine: Up to \$1 million (individual) or \$5 million (non-individual)
- Supervised release: Minimum 4 years

Schedule IV Substances

Drugs and Threshold Quantities:

- **Substances** (including Darvon®, Talwin®, Equanil®, Valium®, Xanax®): Any quantity

Penalties:

First Offense:

- Up to 5 years imprisonment
- Fine: Up to \$250,000 (individual) or \$1 million (non-individual)
- Supervised release: Minimum 1 year

Second Offense:

- Up to 10 years imprisonment
- Fine: Up to \$500,000 (individual) or \$2 million (non-individual)
- Supervised release: Minimum 2 years

Schedule V Substances

Drugs and Threshold Quantities:

- **Substances** (including over-the-counter cough medicines with codeine): Any quantity

Penalties:

First Offense:

- Up to 1 year imprisonment
- Fine: Up to \$100,000 (individual) or \$250,000 (non-individual)

Second Offense:

- Up to 4 years imprisonment
- Fine: Up to \$200,000 (individual) or \$500,000 (non-individual)
- Supervised release: Up to 1 year
